What does Governance mean to the ACHN Working Group

- Structure that allows you to get work done.
- Allows the coordinator to rely on to make decisions who can make
- Communication tool for new members
- Roles and responsibilities
- Process
- Fiduciary responsibility accountability
- In some contexts about board
- Hierarchy reporting

Network & Governance Issues:

- Get work done without being exclusive
- People know how to contribute/connect

"WHAT IS A NETWORK" - watched video and discussed the 3 types of Networks.

- Connectivity network weaving connects people
- Alignment network facilitation
- Production network coordination

"Thinking like a network - Network Mapping

- Networks are always in a state of change, with each change there are new challenges and opportunities
- Keep adapting
- Existing networks are they meeting your needs"

The ACHN networks emphasis is primarily on production recognizing that alignment connectivity is part of that. Production choices are informed by:

- Stories, opportunities, planning, and evidence. (anyone can bring anything forward, network goes out to community so that it is easy to bring things forward
- Consultation collaborative conversations that surface emerging issues.
- Based on urgency
- List of values
- Transparency
- Inclusiveness
